Synopsis : Denton Police arrested Gina Draper, 45, and Rachael Bennett, 37, both of Denton for theft. Police responded to the Just Yesterday consignments shop where employees reported a shoplifting. Employees advised that two females had taken merchandise from the store and did not pay for it. The employees were able to provide descriptions of the suspects and based on those descriptions the two above suspects were able to be identified. Draper was apprehended in the area a short time after the incident occurred. During questioning Draper refused to cooperate with police with regards to the identity of the other suspect. Draper was charged with conspiracy to commit theft and hindering and investigation. Draper was taken before a District Court Commissioner who ordered her released on her personal recognizance.

Police then obtained a warrant for Bennett and that warrant was served on July 19, 2010. Bennett was taken before a District Court Commissioner who ordered her held at the Caroline County Detention Center in lieu of \$4500 bail.
